Substance: Mouse Anti-Drosophila CNS Axon Monoclonal Antibody (CBP1118)

Notes: avoid repeated freeze-thaw cycles.

Hand Protection: Wear latex or vinyl gloves.

Respiratory Protection: Required when vapors/aerosols are generated.
