Substance: iNeuMab™ Rabbit Anti-SMN1 Monoclonal Antibody (CBP3499)

### **3. Hazard Identification**

Notes: avoid repeated freeze-thaw cycles.

Hand Protection: Wear latex or vinyl gloves.

Respiratory Protection: Required when vapors/aerosols are generated.
